Fund objective

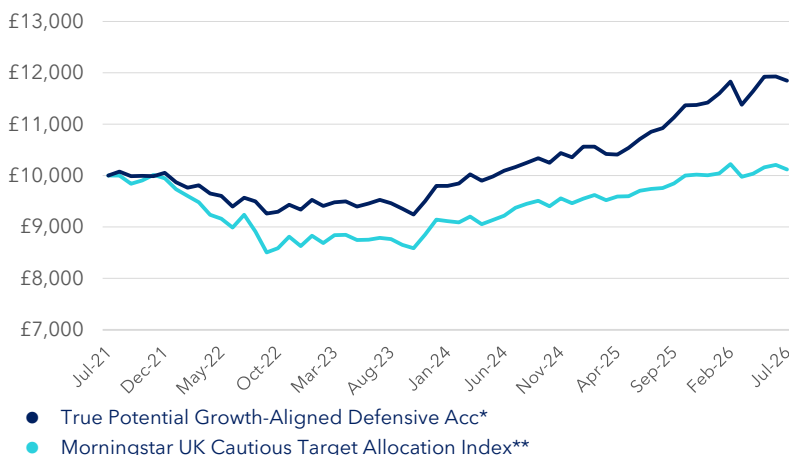
The Fund aims to achieve growth over the long term (5 years or longer).

July Update

Global equities were broadly flat in July amid an escalation in US-Iran tensions and significant declines in semiconductor stocks. Emerging Market (EM) equities fell and underperformed their developed market counterparts, dragged down by South Korea and Taiwan. In developed markets, UK and European shares outperformed, while US growth-style stocks proved a laggard. In fixed income, global sovereign bonds underperformed as yields rose. Elsewhere, gold prices ended broadly flat.

The True Potential Growth-Aligned Defensive Fund returned -0.67% (net of fees), with the Fund's allocations to UK, European and Japanese equities proving supportive, along with the underexposure to US shares. Manager selection was a key contributor as most of the active strategies did well, with a standout performance from the Man GLG Japan Fund. While the Fund's exposure to EM shares detracted overall, the allocation to the Artemis Global EM Fund helped, as it outperformed the broader EM market. In fixed income, the Fund's preference for UK Gilts over US Treasuries had little impact as yields moved broadly in tandem. The allocation to EM debt via the Amundi Core EUR HY Fund (hedged to sterling) also posted declines, while exposure to high-yield bonds via the Amundi Core EUR HY Fund (hedged to sterling) ended flat. In alternatives, the GMO Equity Dislocation Fund produced the best gains overall, while the AQR Managed Futures Fund (hedged to sterling) also did well. Meanwhile, the Fund's exposure to gold via the Amundi Physical Gold Fund detracted.

The OCF of this fund is currently 0.54%. This means that if you invest £1000 in the fund, you can expect to pay £5.40 in fees over the course of a year. The fees you pay are pro-rata. If you hold the fund for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk type	Description
